and Quality (HSEQ)	requirements and other policies, standards, and procedures relevant to the	
	services provided.	
	The supplier must provide:	
	• Safe and healthy working facilities and take appropriate measures to	
	protect employees from work-related hazards and anticipated dangers in	
	the workplace.	
	• Evidence of regular and recorded health and safety training, when required.	
	Clean and safe accommodation that cover basic needs.	
	A system for preventing, reporting, and investigating occupational injury and	
	illness, including standards for fire safety, emergency preparedness and	
	response plans, occupational or industrial hygiene standards, appropriate	
	lighting and ventilation, machinery safeguarding, and other standards	
	related.	
	A management representative for communication and handling of health	
	and safety issues.

Data Privacy and	The supplier must maintain full confidentiality with all sensitive documentation	
Confidentiality	shared by RELIANT.	
Child Labour	Children must not be hired to work before completing their compulsory education. The minimum age for entry into employment must not be less than	
	18 years.	
Forced Labour	The supplier must not use forced, bonded, or involuntary labour.	
Human Rights	The supplier must comply with international Human Rights Regulations and	
	RELIANT's Human Rights Policy.	
Wages and Working Hours	The supplier must not pay less than the minimum wage established by the	
	country where we have operations.	
Non-Discrimination	The supplier must:	
Environment	Provide a work environment where everyone is treated fairly and gender,	
	culture, race, religion, national origin, age, disability, political beliefs, sexual	
	orientation, marital status, or other diversity factors are respected.
